



The investment objective of Profit Seeker Fund ("Fund") is to achieve consistent, above-average monthly returns by trading a fully automated, proprietary trading system managed by Profit Seeker Capital, in partnership with Haystack Genesis LP. The Fund will trade over-the-counter spot currencies in the inter-bank foreign exchange market (Forex) and select exchange-traded futures.

Advantages of Profit Seeker Trading Strategy

Fully-automated trading system

The system consists of a proprietary management module, proprietary application-layer software routines that generate trading signals; and custom interfaces directly with the global Forex market or futures commission merchant. Once the account is established no client actions of any kind is necessary.

Indifferent to market timing, direction, volatility or velocity of market

The trading program is not dependent on any form of speculative market timing or market entry strategy. The system makes no attempt to predict future price movements. Instead, the program looks for and acts upon actual, real time price movements and thrives during periods of extreme volatility.

Systematic, non-discretionary trading

The program is a 100% systematic, non-discretionary trading solution. The system does not rely on fundamental analysis by the client or the Fund manager.

Preservation of principal capital

The system uses a variety of proprietary money management techniques that have been automated and integrated together to ensure the account is never over-leveraged. Aggregate open positions are carefully managed to typically range from approximately 1% to 15% of the principal account balance, thus limiting market risk.

Consistently reliable winning trade percentage with minimal daily drawdowns

The trading works by achieving small, consistent daily returns and has historically produced winning trades on approximately two-thirds of all open positions, with typical maximum drawdowns of 10% or less.

Adaptable to a variety of account sizes and styles

The system's proprietary settings and features can be adjusted solely by the Fund manager based on a variety of factors to achieve the desired risk/return balance ideally suited to each commodity pool or individually managed account. These factors combine to determine position sizes, money management controls, specific profit targets and the approximate number of trades executed daily.
